Requirements for Level 1 Temporary Tutor → Level 1 Training & Assessment Director:

- ☐ BCU Level 1 Temporary Tutor
- ☐ Updated BCU Level 3 Coach
- ☐ Receive a recommendation from a current qualified Training Director confirming they are operating at the required level
- ☐ Satisfactory QA visit (conducted by Home Nation Quality Assurance Officer)
- ☐ Complete a satisfactory tutor assessment such as BCU Tutoring Paddlesport Assessment, or the 1st4sport Certificate in Tutoring sport (Active Qualified Teachers can apply for APL)
- ☐ Complete a satisfactory IV Report (conducted by Home Nation IV Officer)
- ☐ * Either Attend the Sports Coach UK Assessor Training
 - Or Complete the national standards for assessment A1 or A2 Assessor Units
 - Or Take the 1st4sport Certificate in Assessing Sport
 - Or Apply for exemption based on APL
 - Or BCU Assessor Training Course (currently in development)

- ☐ BCU Level 2 Temporary Tutor
- ☐ Updated BCU Level 3 Coach
- ☐ Receive a recommendation from a current qualified Training Director confirming they are operating at the required level

 - Or Complete the national standards for assessment A1 or A2 Assessor Units
 - Or Take the 1st4sport Certificate in Assessing Sport
 - Or Apply for exemption based on APL
 - Or BCU Assessor Training Course (currently in development)
